Silverleaf

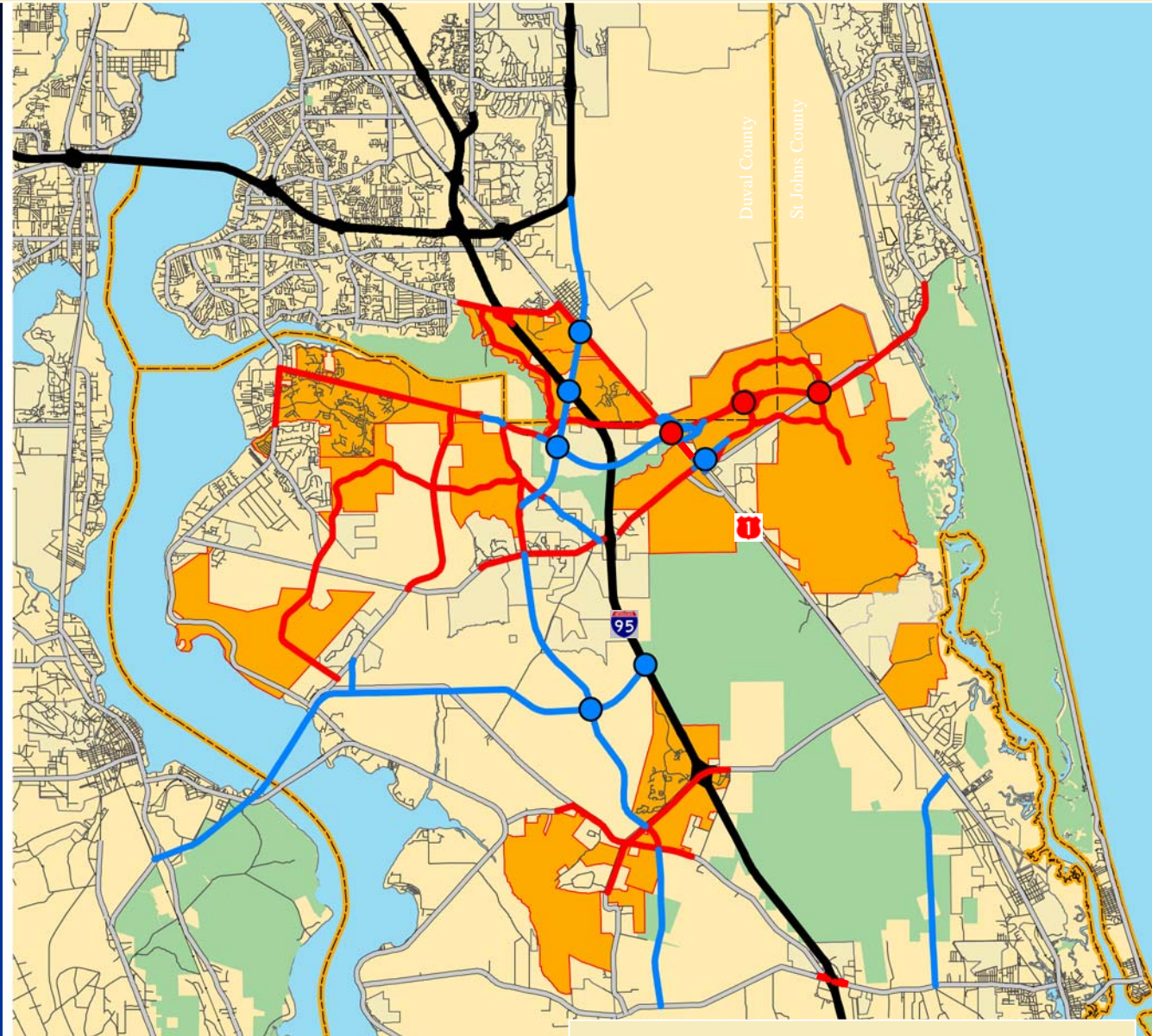
